**INVITATION TO BID FOR THE
Purchase of Sewing Machine for Women's Group Beneficiaries on
Home based Garments Manufacturing at Lubao, Pampanga**

1. The Municipality of Lubao (MOL) through the authorized appropriations under DILEEP and DOLE BUB 2016 intends to apply the sum of One Million Two Hundred Thousand Pesos (P1,200,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Purchase of sewing machine for women's group beneficiaries on homebased garments manufacturing. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Lubao now invites bids for the Purchase of sewing machine for women's group beneficiaries on homebased garments manufacturing. Delivery of the goods shall start fifteen (15) days from receipt of the Notice to Proceed. Bidders should have completed, within two (2) years from the date of bid conference, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (**IRR**) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act."
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
5. Interested bidders may obtain further information from the Municipality of Lubao Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 p.m.
6. A complete set of Bidding Documents may be purchased by interested Bidders on October 22 – November 3, 2016 from the address below and upon payment of a non-refundable fee in the amount of Five Thousand Pesos (P5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Municipality of Lubao provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the

submission of their bids.

7. The Municipality of Lubao will hold a Pre bid conference of November 2 ,2016 at 10:00 a.m. Bids must be delivered to the address below on or before November 10, 2016 8:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be on November 10 ,2016 at 10:00 a.m. at MPDO Office, Mun. of Lubao, San Nicolas I, Lubao, Pampanga Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The bidders shall drop three (3) copies of their duly accomplished eligibility requirement technical and financial proposals in two (2) separate sealed envelopes in the bid box located at the above-mentioned address.
9. The Municipality of Lubao reserves the right to accept or reject any bid, to annul the Bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
