- MUNICIPAL ORDINANCE NO. 96-14 -

AN ORDINANCE REQUIRING DOG OWNERS TO KEEP THEIR PET DOG FROM STRAYING.

SECTION I. Regulated Acts - (a) Owners shall not allow their pet dogs to stray/roam around in any public places, streets and the like; (b) Stray Dog shall be impounded and the owner shall have three (3) days within which to claim it from the impounding authority; (c) Failure to claim the dog within 3 days, the impounding authority can dispose of/sell to recover expenses incurred in keeping it.

SECTION II. Penal Clause - Any person/persons caught violating any provision of this ordinance shall suffer the penalty of fine as follows:

- a) First Offense P 200.00
- b) Second Offense 300.00
- c) Third Offense 500.00

SECTION III. Repealing Clause - Ordinances inconsistent with this Ordinance are hereby repealed.

SECTION IV. Effectivity - This ordinance shall take effect upon its approval and after ten (10) days publication in a newspaper of general circulation.
