**RESOLUTION ADOPTING/IMPLEMENTING R.A. 9514 OTHERWISE
KNOWN AS THE FIRE CODE OF THE PHILIPPINES OF 2008 WITHIN
THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF
LUBAO, PAMPANGA.**

WHEREAS, Republic Act No. 9514 is otherwise known as the Fire Code of the Philippines of 2008;

WHEREAS, the Fire Code embodies the latest standard in fire safety and incorporates all the necessary provision that were not in the old Fire Code to include the new developments in technology and to make the fire safety measures attuned to the growing requirements of public safety;

WHEREAS, the LGU shall have a 20% share from all taxes, fees and charges collected;

WHEREAS, under Memorandum Circular No. 2009-188 of the Department of the Interior and Local Government (DILG), all city and municipal mayors are required to implement in their respective jurisdiction the general guidelines for the efficient and effective assessment the collection and utilization of the Fire Code revenues wherein 20% shall go to the respective LGU;

**NOW, THEREFORE, THE SANGGUNIANG BAYAN OF LUBAO,
PAMPANGA, IN SESSION ASSEMBLED, BE IT –**

RESOLVED, as it is hereby resolved, adopting/implementing R.A 9514 otherwise known as the Fire Code of the Philippines of 2008 within the territorial jurisdiction of the Municipality of Lubao, Pampanga;

RESOLVED FURTHER, that a copy of this resolution be forwarded to the Office of Mayor Dennis G. Pineda, Lubao, Pampanga, for his information and appropriate action;


RESOLVED FINALLY, that other copies of this resolution be furnished to all offices concerned, for their information and guidance;
