KNOW ALL MEN BY THESE PRESENTS

This CONTRACT AGREEMENT made and entered into this 30th day of May 2017 by and between:

The Municipal Government of Lubao, Pampanga represented herein by HON. MYLYN P. CAYABYAB Municipal Mayor (and hereinafter called the Owner) as party of the First Part, and V. TRILLANA BUILDERS. & TRADING herein represented by MR. VALENTIN TRILLANA JR. and herein after called the Contractor) as Party of the Second Part.

WHEREAS, The Party of the First Part is desirous that certain works should be improved viz : Conc. of Prado Siongco Brgy. Road. at Prado Siongco, Lubao, Pampanga and has accepted that bid by the Party of such work in the total Contract amount of : ONE MILLION NINE HUNDRED NINETY THREE THOUSAND TWO HUNDRED FIFTY PESOS & 15/100 (P 1,993,250.15) broken down as follows.



5. That the **CONTRACT** shall not effect until the **CONTRACTOR** has furnished and delivered to the **EMPLOYER** in form and amount as required in the Instruction to Bidders.
6. The **CONTRACTOR** shall comply with and strictly observe all laws regarding workmen's health and safety, workmen's compensation for injuries, minimum wages, hours of labor and other Labor Laws as per Ministry Order No. 9, Series of 1981
7. The **CONTRACTOR** warrants that he has not given nor promised to give any money or gift to any employee of the **EMPLOYER** (or any Philippine Government Instrumentalities) to secure this **CONTRACT**;
8. The Joint Guidelines on Change Orders, etc. as provided under the pertinent provisions of the Implementing Rules and Guidelines of the R.A. 9184 are hereby incorporated as part of this **CONTRACT**;
9. In case the **CONTRACTOR** fails to satisfactorily complete the Works within the specified Contract Time (which will include any time suspension/extensions duly granted), the **CONTRACTOR** shall pay the **EMPLOYER** the relevant sum as liquidated damages for such default and not by way of penalty, as provided in the conditions of the contract, equal to at least (1/10) of one (1) percent of the cost of the unperformed portion of the works for every day of delay




